FROM THE PRESIDENT

About six years ago, I had the incredible pleasure and good fortune to collaborate with Jim Eychaner, former NARRP President, on a project for the Washington Recreation and Conservation Office (previously the Interagency Committee for Outdoor Recreation). As we drove across Washington State going from one public meeting to the next, we talked a lot about NARRP and he encouraged me to join the Board. I'll admit, while I was extremely excited about the



opportunity to potentially serve on the Board, I had no idea what I was getting myself into!

I started as Secretary, moved on to Vice President of Operations, and am now President. During this time, the Board went through a restructuring and we became a 501(c)(3) organization. In addition, we continued to develop and publicize significant best practices, core principles, and position papers that advocate strongly for rigorous planning processes that help maintain and promote the great outdoor recreation spaces we have in this country. All the while the Association continued to provide valuable services and networking opportunities for our members, including our outstanding annual conference. Personally, I had no idea this opportunity to serve as a Board member would turn out to be so interesting, so stimulating, so invigorating, and ultimately so gratifying. I am indebted to Jim and want to take this opportunity to thank him publicly for getting me involved with NARRP (and of course for everyone who voted for me during the last Board election!).

It's been another exciting year for the Association. A few highlights from 2011:

Innovations in Connecting Americans to our Great Outdoors Conference connecting our citizens to the outdoors is key if we are to improve health, reinvigorate local economies, and instill a new generation of land stewards. The 31st Annual NARRP Conference in Breckenridge, CO, provided an opportunity to explore and learn from each other's successes and challenges in connecting

people to the great outdoors. As usual, it also provided an opportunity for us to share stories, experience the great outdoors of Colorado, and enjoy the company of fellow recreation planning professionals.

- 2011 Special Achievement Award NARRP honored Ken Salazar, Secretary of the Interior and Nancy Sutley, Chair of the White House Council on Environmental Quality and Interagency AGO Coordinating Council, with NARRP Special Achievement Awards. Through the award, the Association recognized their integral roles in the America's Great Outdoors Initiative, as well as their leadership in protecting and ensuring all Americans can access and enjoy parks and public lands for generations to come.
- SCORP Excellence Award the National Park Service and NARRP awarded the SCORP Excellence Award to the Pennsylvania Department of Conservation and Natural Resources. Pennsylvania's award winning SCORP was recognized for its work to transform outdoor recreation planning and get residents to spend more time outdoors.
- **New Brochure** the Membership and Communications Committee, with Board input and approval, redesigned the NARRP brochure. The updated brochure helps communicate the role and benefits of NARRP in a graphic and professional manner.
- Reframing the Role and Relevancy of Statewide Comprehensive Outdoor
 Recreation Plans (SCORP) building off our Support for The Great Outdoors
 America (September 2009) position paper, as well as productive sessions from
 several of our conferences, the Board authored a position paper on the future of
 SCORPs. The 12 recommendations included in the paper are intended to make
 SCORPs more effective and efficient for States and their outdoor recreation
 communities, as well as help complement the successful implementation of the
 America's Great Outdoor initiative.
- New Student Liaison Position the NARRP Board, in an effort to strengthen our ties to academia and specifically students, created a new student liaison position. The one-year term is open to graduate students enrolled in an outdoor recreation planning or related academic program. After a thorough application process, The NARRP Board voted to appoint Zac Cole, a PhD candidate at the University of Florida, as the first NARRP Student Liaison.

In the coming year, the Board will pursue new and exciting avenues to strengthen the Association and advocate for comprehensive planning processes. We will continue to be a strong advocate for outdoor recreation planning and the greater outdoor recreation and conservation profession. We look forward to these challenges and anticipated rewards and hope you all continue to engage in and support this amazing Association.

- Conference is a great opportunity for education and networking but with budget constraints, members are concerned that they won't be able to attend.
- The website is not well known and not very well used.
- The use of social media by members is growing.
- Based on the survey results, the following recommendations were made to the Board:
 - A moderate dues increase was proposed and implemented on January 1, 2012.

Dues are now: Regular \$80

Student \$35 Retiree \$35

Institutional \$80 first member, \$70 each additional member

- A new website is being developed and will go live in late winter/early spring 2012.
- More attention will be focused on LinkedIn and Facebook as marketing and communication tools for the association.
- Continue to develop the chapters in the planning book to promote the planning principles for recreation resources planners.

BEST PRACTICES IN RECREATION PLANNING BOOK UPDATE

In January, 2012 the NARRP Board voted to allow Venture Publishing, a commercial publisher of academic textbooks, to publish the existing book chapters and remaining chapters as a hard copy textbook. The book is scheduled for completion in December, 2012. The benefits of having Venture publish the Best Practices book include producing a more comprehensive source of information, completing the book project more quickly, and having the ability to promote the book with a much wider audience of prospective users.

Dr. John Baas and Dr Robert Burns will serve as editors in chief and work directly with editors from Venture Publishing to complete the book. In addition to maintaining its practitioner's focus, the hard copy textbook will be a resource that will be used as a teaching guide in college courses on outdoor recreation resource planning. The chapters that have been completed to date will be updated as appropriate, and in some cases will be combined so that each chapter is approximately 15 pages. As a result, the final product will have a different look and feel than what had been hosted on NARRP's website. Academics and practitioners will work together to write the remaining chapters which include the following:

- Alternatives development and analysis.
- Planning and decision-making.
- Managing the recreation resource planning process.
- Implementation planning.
- International perspectives on recreation resource planning.
- Emerging Issues.

The Education and Professional Development Committee oversees all NARRP scholarship programs including promoting, advertising, selecting recipients, and maintaining accurate records of all recipients and funds disbursed. Individual scholarship programs are reviewed by the Scholarship on an annual basis. The committee will administer the Special Projects Scholarships and Professional Development Grants when deemed feasible. The committee has expanded responsibilities to include management of the NARRP's academic programs webpage and coordinate additional education and professional development related projects and opportunities that become available (e.g. the National Recreation and Park Association (NRPA) Council of Accreditation (COA).

2011 Committee Accomplishments

- Ten student conference scholarships were awarded to undergraduate and graduate students representing seven universities all across the country from the University of Maine to the California State University, Chico.
- Raised \$3407 at the 2011 Breckenridge Conference's silent and live auctions for NARRP's Student Scholarship Fund.
- Broadened the committee to encompass NARRP educational and professional development goals.
- Appointed an outdoor recreation planning student liaison as a non-voting Board member, Zac Cole from the University of Florida.

- Consider a student research scholarship.

DEVELOPMENT COMMITTEE REPORT

Financial Development

NARRP was able to generate over \$15,000 from sponsors and exhibitors at the 2011 conference in Breckenridge, plus the silent and live auctions generated \$3407 for future student scholarships.

The largest single gift was a \$5,000 sponsorship from The Active Network for the 2012 Conference, which was then matched by membership donations for a total of \$10,000. These monies are earmarked to help ensure a successful 2012 annual conference in Baton Rouge.

While these gifts and activities may be modest relative to other national organizations, NARRP has taken a large step in moving towards an annual gifting target of \$20K.

Policy Development

The most significant policy product in 2011 was the position paper submitted to the Secretary of the Interior titled Reframing the Role and Relevancy of Statewide Comprehensive Outdoor Recreation Plans. The paper is posted on our website and has been the catalyst for considerable discussion among states, National Association of State Outdoor Recreation Liaison Officers (NASORLO), and the Federal Interagency Council on Outdoor Recreation (FICOR). Two panel sessions are planned for the 2012 annual conference to further this topic.

NARRP has maintained a close working relationship with Interior officials and federal agencies on the America's Great Outdoors initiative, attending a number of meetings and conference calls.

Plans have also started for a Land and Water Conservation Fund (LWCF) Re-authorization Forum in 2013. Since the LWCF fund expires in September 2015, NARRP wants to provide leadership and initiate discussion soon on how to strengthen the original 1965 LWCF Act in hopes of another 50 years.

Board Development

The NARRP Board had a healthy discussion at its mid-year meeting about how to strengthen the Board in terms of skills, experience, and diversity. A self-diagnostic tool was used to help the Board reflect on itself. Awareness was raised and the prospect of some facilitated special board development training in the future seems likely.

Federal Interagency Council on Outdoor Recreation

The number one recommendation by NARRP in our <u>2009 Support for the Great Outdoors America</u> position paper was to "Establish Inter-Departmental National Leadership" for outdoor recreation. NARRP is proud to take some credit for planting the idea of establishing what has become the Federal Interagency Council on Outdoor Recreation (FICOR).

By good fortune, the lead of the FICOR working group in 2011 was Bob Ratcliffe, former Bureau of Land Management Recreation Director and recipient of the NARRP National Leadership Award in 2009. Our connection with Bob paved the way for Glenn Haas, NARRP VP for Development, to assist FICOR in its foundational year.

Another outcome of NARRP's connection with FICOR is that several sessions at the 2012 NARRP conference will address issues of key concern to FICOR. Additionally, NARRP submitted a letter in January 2012 suggesting five actions that NARRP would be willing to assist FICOR with.

As a professional society for outdoor recreation planners, managers, researchers and decision makers, NARRP wants to support FICOR in the years to come.

THIRD ANNUAL SCORP EXCELLENCE AWARD

Pennsylvania has earned top national honors for its work to transform outdoor recreation planning and get residents to spend more time outdoors, the Department of Conservation and Natural Resources said today.

The state's five-year Statewide Outdoor Recreation Plan was honored as the best in the nation by to the National Park Service and the National Association for Recreation Resource Planners at a recent conference.

"We are very proud to receive this award recognizing our work," Department of Conservation and Natural Resources acting Secretary Richard J. Allan said. "Our plan is both unique and useful for DCNR and its partners as we work to encourage citizens to be active outside, develop a love and appreciation for nature, improve physical and mental health, and instill a conservation ethic."

Pennsylvania's five-year plan was released in November 2009 to help policy-makers and communities deal with a changing population that is increasingly more urban, and whose children have been spending less time outdoors.

Four surveys supporting the plan showed that families are spending less time outdoors; children are more obese than ever before; and residents are calling for access to close-to-home recreation, walkable and bikable communities, protected lands and waters, and well-maintained park facilities.

The plan identified walking for pleasure or fitness as the most popular outdoor recreation activity in Pennsylvania. Other popular activities include sightseeing and driving for pleasure, nature watching, swimming, picnicking and bicycling.

The plan outlines 28 programoriented and five funding recommendations as action steps.

"Congratulations to the authors of Pennsylvania's outdoor recreation plan, which closely aligns with the federal America's Great Outdoors

Initiative and its focus on

conservation, recreation and connecting people to the great outdoors," said U.S. Department of the Interior acting Assistant Secretary Will Shafroth.

Representatives from the U.S. Department of the Interior and the National Park Service met with DCNR and outdoor recreation stakeholders in Harrisburg recently to identify top project-specific ideas where the state and federal governments might work together on conservation, recreation and historic preservation efforts.

States must update outdoor recreation plans every five years in order to continue to be eligible for related federal dollars.

FINANCE COMMITTEE REPORT

NARRP's total assets and liabilities for the year ending December 31, 2011 was \$79,792. This amount represents a net increase of \$19,000 from the previous calendar year. Total gross income from membership, conference and investments was \$120, 212. The best performing investment was the Vanguard High Dividend Yield ETF at 2.9%. As agreed upon by the Board of Directors, \$4,669 from the net conference income was transferred to the scholarship savings account.


